Mr. Blakeley received a B.A. from New College in Sarasota, Florida (1975) and a J.D. from the University of Pennsylvania Law School (1979). His law course of study included classes in administrative law, regulated industries, international law and antitrust law. Mr. Blakeley served as a member of the Board of Editors and a Comment Editor on the *University of Pennsylvania Law Review* from 1978-79. Following graduation from law school, Mr. Blakeley served for one year as a law clerk to Judge Max Rosenn on the U.S. Court of Appeals for the Third Circuit.

Mr. Blakeley has worked in private legal practice for over twenty-five years, including for some of the premier law firms in the United States. These have included, for example, Wilmer, Cutler & Pickering in Washington, D.C., which Mr. Blakeley joined as an

associate after leaving his judicial clerkship, and Sidley & Austin, where Mr. Blakeley was a partner from 1990 to 1994.

Throughout this time, Mr. Blakeley has focused on a broad range of legal, policy, legislative, and regulatory issues associated with telecommunications (including the Internet), broadcasting, intellectual property and technology. Mr. Blakeley has worked on issues concerning television and radio broadcasting (both in the U.S. and elsewhere), wireless communication (cellular, PCS, and paging), local and long-distance wireline communications (including international communications between the U.S. and other countries), Internet (including Voice Over Internet Protocol – “VOIP”), e-commerce, e-government, cybercrime, satellites and earth stations, microwave, cable television, and regulated equipment approval. He has advised providers and users of communications, as well as governmental agencies and NGOs on a broad range of legal and policy issues concerning telecommunications and the Internet, as well as on intellectual property issues, including copyright and trademark matters (creation, protection, enforcement, licensing, and compliance with international standards and best practices), e-commerce and cybercrime/cybersecurity matters. His practice also includes representation of companies before the U.S. Federal Communications Commission, the U.S. Patent and Trademark Office, the U.S. Copyright Office, state regulatory authorities and federal and state courts.

In 1998, Mr. Blakeley helped found the Enterprise Law Group LLC. Subsequently, in January 2000, he founded the Alliance Law Group LLC, a successor to the Enterprise Law Group. Alliance Law Group is focused on providing legal and policy advice on matters concerning technology. These include telecommunications, Internet, e-government and e-commerce, and Intellectual Property matters.

Mr. Blakeley’s practice has a strong international component, particularly in the Middle East, where he has been active since 1995, originally on a broadcasting related project for the Palestinian Authority. His work internationally has involved policy level consulting for both governmental agencies and NGOs on a broad range of issues concerning telecommunications reform, liberalization and privatization, Intellectual Property Rights enforcement and compliance (including compliance with TRIPS and other international agreements), Internet, cybersecurity, e-commerce and e-government, compliance and conformity with international standards and best practices, the relationship of these issues to economic development, and recommendations for and drafting of new laws or amendments to existing laws, as well as representation of commercial clients.

As part of Mr. Blakeley’s international work, he has been part of several consulting teams and has headed two consulting teams that conducted major research/consulting projects for governmental agencies. As part of those projects, he has written and edited extensive documents and also has worked closely with and advised senior policymakers and government officials. He has also advised U.S. companies on matters relating to their overseas operations and has represented foreign companies with respect to their activities in the U.S. In that capacity, he has worked with and advised senior executives at those companies.

Mr. Blakeley also has experience in litigation matters. He has briefed and argued cases in the U.S. Courts of Appeals and has served as co-counsel on *amicus curiae* briefs before the U.S. Supreme Court. SPECIFIC EXPERIENCE:

Virginia, United States (2011) – Land Use/Zoning Law

Mr. Blakeley successfully represented a private landowner in a legal action challenging the action of the Fairfax County Board of Supervisors in granting a “special exception” for a residential lot width waiver. The Fairfax County Circuit Court ruled that the Board had violated state law in adopting the ordinance authorizing such special exceptions and that the ordinance, and the Board’s grant of a special exception pursuant to the ordinance, were invalid. This decision is believed to be the first such ruling on this issue in Virginia.

Jordan (2011) – Telecommunications Law

On behalf of the Jordanian Ministry of Information and Communications Technology, Alliance Law Group will conduct a study of international best practices in the area of media convergence and will recommend appropriate revisions to the Jordanian Telecommunications Law.

Ramallah, West Bank (2011) – E-Commerce, E-Government & Intellectual Property

In this U.S. government funded project, Mr. Blakeley is assisting the Palestinian Ministries of National Economy (MONE) and Telecommunications and Information Technology (MTIT) in revising the legal structure for the e-government and e-commerce system in the Palestinian Territories so as to bring it into conformity with international best practices. Among other things, this includes assisting in drafting an e-transactions law as well as related laws on such issues as cybercrime and data privacy. He is also working with the MONE and the Palestinian Ministry of Culture to revise the intellectual

property laws to bring them into compliance with the TRIPS Agreement and with other international best practices.

United States (2010 – 2011) – International Telecom Acquisition

Mr. Blakeley represented a U.S. company with respect to its possible acquisition of an international telecommunications company. Mr. Blakeley assisted in the negotiations and preparation of the acquisition agreement.

United States (2010 - present) – Global Information Technology Law

As part of this project, he conducted detailed meetings with the relevant ministries, held several public roundtables and seminars with interested stakeholders (including NGOs and private sector companies) and gave public presentations about the importance of e-commerce, international best practices, and the legal structure for e-commerce in Azerbaijan.

The two organizations continue to discuss follow-up steps to be undertaken both in the U.S. and Lebanon on issues such as intellectual property rights, telecom reform, and cybercrime.

Macedonia (2004) Ministry of Culture (WTO Compliance Project)

In a USAID-funded project, Mr. Blakeley advised the Ministry on the compliance of the Macedonian Copyright Law with WTO Standards/TRIPS Agreement.

Lebanon (2004) Ministry of Economy & Trade (WTO Accession Project)

In a USAID-funded project, Mr. Blakeley advised the Ministry concerning the compliance of the Lebanese Copyright Law with WTO standards/TRIPS Agreement and suggested appropriate changes to the Lebanese law. The plan was designed to assist the Telecommunications Regulatory Commission (TRC) in the steps required to ensure a competitive regime for fixed line telecom services.

West Bank, Palestine (2000) Telecommunications & Internet Reform

Under the auspices of the Palestinian Information Technology Association (PITA), Mr. Blakeley conducted a series of public and private meetings with the Palestinian Ministry of Communications, the Palestinian Telephone Company (“Patel”), and others concerning telecommunications and Internet reform. Issues concerning regulation of Country Top Level Domains (CTLDs) also were discussed.

United States (2000 - 2001) Wireless Broadband Provider

Mr. Blakeley worked with a large, international company, in its effort to obtain new wireless radio frequency spectrum in the United States. The company intended to use this spectrum to provide high-speed wireless Internet connectivity to various handheld devices, such as those based on the Palm Operating System. The efforts were focused on the Federal Communications Commission in the U.S. but also required knowledge of international rules and regulations governing spectrum allocation and use.

United States (1999 – 2007) Online Education Provider

Mr. Blakeley represented a provider of on-line technology training for students and teachers. Mr. Blakeley served as its outside general counsel and provided advice on a broad range of corporate, technology, and other issues. This included contract, intellectual property, e-commerce, and related legal issues.

United States (1999) Internet Defamation

Mr. Blakeley served as co-counsel for the plaintiff in this trial court litigation, which resulted in successfully removing the defamatory language from an Internet web site.

This included advising the company on negotiations with incumbent Bell Operating Companies and analyzing the meaning and application of relevant provisions of the Telecommunications Act of 1996.

United States (1997-1998) Voice Over the Internet

drafting a legal charter for the PBC. Issues addressed by Mr. Blakeley and his team included the relationship between the Palestinian Authority and the PBC and regulation of content by the PBC, including political advertisements by candidates for election to the Palestinian Parliament. Mr. Blakeley and his team prepared proposed laws dealing with political broadcasting issues.

United States (1994 – 1995) Long-Haul Optical Fiber Network

Mr. Blakeley helped negotiate a series of agreements that established a local optical fiber network and that interconnected that network with a long-distance optical fiber network that transported telecommunications signals on the East Coast of the United States.

United States (1992 – 1995)

Mr. Blakeley organized a coalition of broadcasters in response to an attempt by several political candidates to pursue claims in state court for alleged overcharges by broadcasting stations for political advertising time.
